

The Roman Catholic Church of the Archdiocese of New Orleans as owner and operator of Archbishop Hannan High School (hereinafter "AHHS"), a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code, is conducting the Archbishop Hannan High School Car Raffle. By entering this raffle, entrants accept and agree (1) to be bound by all the rules, limitations and restrictions set forth here and (2) that their names and/or likenesses may be disclosed to and used by the news media and may otherwise be used by Archbishop Hannan High School (AHHS) for publicity purposes related to this raffle and in lists of prize winners. Other rules and regulations may apply. Please contact AHHS if you have questions. AHHS's interpretation and application of the rules and regulations shall be final.

The Grand Prize Drawing for the Raffle will be held on April 2, 2020. The winner does not need to be present to win. The Grand Prize winner shall assume all responsibility for fees, local, state and federal taxes, sales tax, and/or financing costs which must be paid prior to the prize being transferred to the winner. Consult your tax advisor. This offer is void where prohibited by law, and all federal, state and local laws and regulations apply.

By entering this raffle, each participant releases AHHS, its directors, officers, employees and agents from any and all liability for injuries, losses, or damages of any kind caused by participating in the raffle or winning any prize or resulting from acceptance, possession, use, or misuse of any prize, and each winner agrees to indemnify and hold AHHS harmless from any and all losses, damages, rights, claims, and actions of any kind arising in connection with or as a result of participating in the raffle or the winner's acceptance or use of any prize.

1. **Tickets:** The purchase price of each ticket costs \$20.00 and is non-refundable. Each ticket is one chance to win the raffle prize. Division of a prize by a group purchasing a ticket in common shall be the sole responsibility of the person named as the holder of record of that ticket, should that ticket be selected as a winner. AHHS reserves the right to reject any ticket that is submitted with payment that does not constitute "good funds." All orders for tickets must be received and/or purchased by the indicated deadline. AHHS assumes no responsibility for lost, late, misdirected, or non-delivered mail or messages, or any other failure to receive orders or deliver receipts prior to the drawing deadlines. A raffle participant's sole and exclusive remedy for AHHS's breach shall be limited to the return of the purchase price paid for his or her raffle ticket(s), which remedy shall be in the sole and exclusive discretion of AHHS. In no event shall AHHS, its directors, officers, employees, agents, or representatives be liable to any party for any loss or injuries to earnings, profits, or goodwill, or for any incidental, special, punitive, or consequential damages of any person or entity whether arising in contract, tort, or otherwise, even if advised of the possibility of such damages.
2. **How to Purchase:** An individual can purchase as many Raffle tickets as he or she may wish, subject to availability. No refunds are available except in the exclusive discretion of AHHS.
3. **Selection of Winners:** The drawing will be held at the Archbishop Hannan High School Golf Tournament, scheduled at Tchefuncte Country Club on April 2, 2020. A minimum of 2,500 tickets must be sold by April 1, 2020 for the Grand Prize Drawing to take place. In the event less than 2,500 raffle tickets are sold before the drawing, the raffle may be extended, and the drawing will be held after a minimum of 2,500 tickets have been sold.
4. Should the Grand Prize winner not claim their prize within 180 days of the Grand Prize drawing date, the Grand Prize will be forfeited, and another winner will not be selected.
5. In order to collect his or her prize, a Raffle ticket winner may be required to sign and deliver to AHHS: (a) a sworn affidavit of eligibility in accordance with these Rules and applicable law, including without limitation that he or she is at least 18 years old at the time he or she purchased the winning Raffle ticket; (b) such written information as is required by any applicable tax and/or real estate laws, including without limitation his or her Social Security Number; and (c) proof of identity in forms satisfactory to the AHHS showing that the person claiming the prize is the same person who is named on the winning Raffle ticket. The Grand Prize winner may be required to submit a W-2G, W-9, Form 5754 or similar tax form (provided by AHHS) for tax withholding purposes.
6. **Eligibility:** Anyone 18 years of age or older at the time of the purchaser's Raffle ticket purchase may enter. All federal, state, and local laws and regulations apply. The Raffle is void where prohibited or restricted by law. An affidavit of eligibility may be required from prize winners.
7. **Prize:** The Grand Prize is a 2020 Chevy Blazer ("vehicle") provided through Bill Hood Chevrolet (dealer), Stock # 20264, MSRP of \$38,375. The vehicle is subject to availability at the automobile dealer selected by AHHS and may be substituted with a comparable vehicle by AHHS. The vehicle will be transferred to the Grand Prize winner "as is, where is, and with all faults". AHHS does not make or provide any representation, guarantee, or warranty, expressed or implied, in connection with the vehicle and accepts no liability or responsibility regarding the construction or condition of the vehicle. AHHS does not warrant that the vehicle is of merchantable quality or that it can be used for any particular purpose. No express warranties are given and no affirmation of AHHS by words and/or actions will constitute a warranty.
8. At the time that the winner claims the prize, all federal and state income taxes and sales tax based on the value of the vehicle, will be due from the winner. AHHS makes no guarantee that the Internal Revenue Service (IRS) will accept the value of the

vehicle estimated above for the purpose of determining any income tax that may be due from the winner. AHHS takes no responsibility for any tax liabilities. Consult your tax advisor.

9. By purchasing a Raffle ticket and choosing to participate in the raffle, each raffle participant acknowledges and agrees that AHHS has the right, in its sole discretion, to elect not to proceed with the Raffle for any reason whatsoever or for no reason, and in such event, a participant's sole and exclusive remedy, as determined in the sole and exclusive discretion of AHHS, shall be to receive a refund of the full price paid by such participant for each raffle ticket purchased, without interest.
10. Governing Law and Venue. Terms and conditions shall be governed by and construed in accordance with the laws of the State of Louisiana, without giving effect to the principles of conflict of laws of the State of Louisiana, and federal law. Any disputes relating to the Raffle must be held in courts of competent jurisdiction in St. Tammany Parish, Louisiana.
